## ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

### ARTICLE I

#### Name

The name of the corporation shall be: CHARLES R. DREW ALUMNI ASSOCIATION INCORPORATED.

### ARTICLE II

#### Principal place of business and mailing address

The principal place of business and mailing address of this corporation shall be:

### ARTICLE III

#### Purpose(s)

The specific purpose(s) for which the corporation is organized is(are): (A) To become a non-profit organization for the purpose of continuance with the educational process for African American and other needy youngsters, (B) To address the educational and personal developmental needs of the youth who live in the local community, (C) To provide counseling and mentoring service (D) To assist in identifying financial resources for scholarships, (E) To assist youngsters in accessing funds toward furthering their education, (F) To plan, develop, coordinate and provide programs for children and families within the community.

### ARTICLE IV

#### Manner of election of directors

The manner in which the directors are elected or appointed is as follows: Officers and Board Members were elected by the Drew High Planning Committee by a majority vote. All officers are elected for a term of two years. There is presently a nine seat board, Vacated positions can be filled by election at next regular meeting for remainder of unexpired term.

Directors shall be elected as stated in the by laws.

#### ARTICLE V

##### Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited are as follows: Taking responsibility for the affairs, business, and property of the corporation, ensuring that the officers and board members carry out the affairs of the corporation and fulfill it's purpose to the highest level of quality.

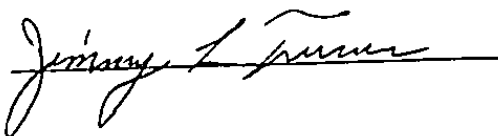
