The undersigned, for the purpose of forming a corporation not for profit pursuant to the provisions of Chapter 617, Florida Statutes (1991), do hereby agree as follows:

Article I - Name

The name of this corporation is SPACE COAST BASKETBALL, INC.

Article III - Purpose
