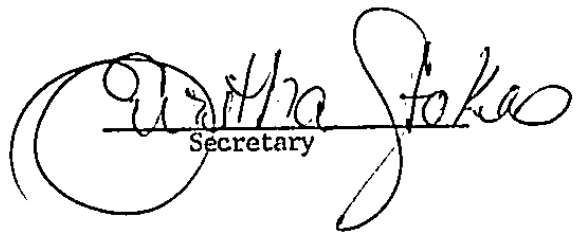

ARTICLE I

The name of the Corporation is THE DELIVERANCE OUTREACH MINISTRIES, INC.

ARTICLE II

DURATION

The term of existence of the Corporation is perpetual.

ARTICLE III

PURPOSE

The purpose for which the Corporation is Organized are:

1. To promote, promulgate, establish, and disseminate the religious beliefs as held by this body of people known as THE DELIVERANCE OUTREACH MINISTRIES, INC., according to their interpretation of the Holy Scriptures, of the Word of GOD.
2. To acquire, own, hold, lease, mortgage, sell and convey real estate for Church purposes and for the benefit of THE DELIVERANCE OUTREACH MINISTRIES, INC, and for all purposes hereafter set forth.
3. To receive donations of property of all kinds and money, legacies, devises, gifts, and donations of property (real, personal, or mixed) for church purposes and benevolent, charitable, humanitarian, scientific, religious, philanthropic, literary and educational purposes mentional in this Article.
4. To extend money for any aforesaid purpose.
5. To receive, hold, and disburse trust funds given or placed in trust with this Corporation for any and all of the aforesaid purpose.
6. To make donations of monies and properties (real, personal, and mixed), to any other religious, charitable, philanthropic, literary, benevolent, humanitarian, educational, or scientific entities, for any and all of the herein described purposes.
7. To purchase, own, acquire, or sell and dispose of membership shares, certificates of indentedness, bonds, and stocks of any other corporation, person, of association of persons, for any and all of the herein described purposes.
8. To do any and all things whatsoever usually done ordinarily done by a church, corporation, religious, literary, charitable, benevolent, philanthropic, or scientific organization or corporation.
9. To have, and exercise, all the rights, privileges, duties, and powers conferred by the laws of the State of Florida and to engage in any lawful purposes, not for pecuniary profit.
10. To several clauses contained in this general statement of the objects of this corporation shall be constructed as both purposes and powers and shall in no way limit or restrict the terms of any other clause.

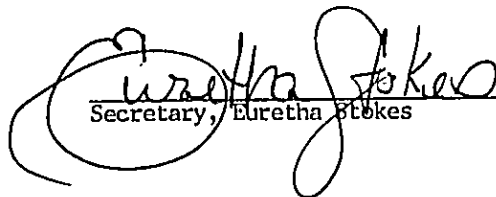

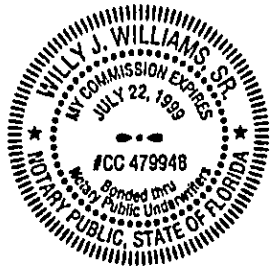

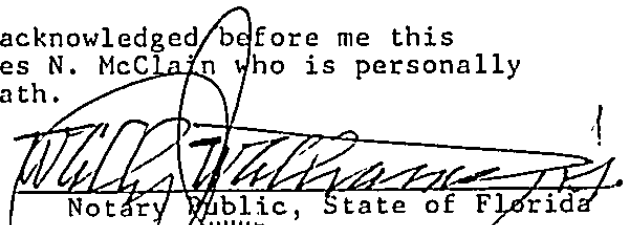
