ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator(s) of a corporation to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be:

International Faith Ministries of Orlando, Inc.

ARTICLE II

The principal place of business and mailing address of this corporation shall be:

425 Fairvilla Road Ste 3
Orlando, FL 32808

ARTICLE III

The specific purpose(s) for which the corporation is organized is(are):

Holding worship services, evangelistic meetings, organizing various ministry groups, and holding services in other states and countries. This corporation will also house a growing congregation.

ARTICLE IV

The manner in which the directors are elected or appointed is as follows:

Directors will be voted in by the members on the congregation at an annual meeting.

ARTICLE V

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited are as follows:

1. The President

The current President, Roger S. Richardson has unlimited powers and cannot be voted out of office by any board member or members, director or directors, staff or administration members or member or members of the congregation. The Senior Pastor is also the President and cannot be voted out of this position by any board member or members, director or directors, staff or administration, member or members of the congregation. The President can also override or veto any decision made by the board, any director or directors, staff and or administration members, and member or members of the congregation.

2. The Executive Vice President

The current Executive Vice President, Marcia V. Richardson, has limited powers. She cannot be voted out of office by any board member or members, director or directors, staff or administration member or members, member or members of the congregation. This office can be replaced only by the discretion and approval of the President. All issues brought forward by the Executive Vice President must be voted on by the board or approved or denied by the President.

3. The Vice President

The current Vice President, Donald DuPree has limited powers. He cannot be voted out of office by any board member or members, director or directors, staff or administration member, or member or members of the congregation. This office can be replaced only at the discretion and approval of the President. All issues brought forward by the Vice President must be voted on by the board or approved or denied by the President and the Executive Vice President. The Vice President is also the Assistant Pastor and cannot be voted out of this position by any board member or members, director or directors, staff or administration member or members, member or members of the congregation, but can only be replaced at the discretion and approval of the President.

4. The Secretary

The current Secretary Annanda DuPree has limited powers. She cannot be voted out of office by any board member or members, director or directors, staff or administration members or members or members of the congregation. This office can be replaced only at the discretion and approval of the President and Executive Vice President.

5. All other board members must bring all issues before the board for a vote or to the President for approval or denial.
6. Positions on the board or as any directors are not transferable,
7. Article V of these Articles cannot be changed, deleted, modified or override by any except the President and the executive Vice President. The board members or directors cannot vote to change Article V or these articles.
