The undersigned, acting as incorporator of a corporation under the non-profit Corporation Act of the State of FLORIDA, adopt the following articles of incorporation.

ARTICLE L

The name of the corporation is:

ARTICLE II

The corporation's duration shall be perpetual.

ARTICLE III
