ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the non-profit Corporation Act of the State of FLORIDA, adopt the following articles of incorporation.

ARTICLE I

The name of the corporation is:

EL FARO CENTRO CRISTIANO, INC.

ARTICLE II

The corporation's duration shall be perpetual.

ARTICLE III

The purposes for which the corporation is organized are to engage in any activity permitted under the laws of the United States (in which a non-profit corporation in this state is permitted to engage), through the promotion of educational activities, which result in educational benefit to recipients designated by the corporation.

ARTICLE IV

The qualifications for members and the manner of their admission shall be regulated by the by-laws.

ARTICLE V

The initial street address of the initial registered office of the corporation is 1299 SW 112th WAY, FT. LAUDERDALE, FLORIDA 33325 and the name of the initial registered agent at such address is JUAN GONZALEZ.

#### ARTICLE VI

The initial board of directors shall consist of at least three members, who need not be residents of the State of FLORIDA. Directors shall be elected at the annual meeting by the members.



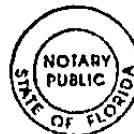
