ARTICLE I NAME

The name of this corporation shall be ALL GOD'S CHILDREN, INC.

ARTICLE II DURATION

This corporation shall exist perpetually.

ARTICLE III PURPOSE

The purposes of this corporation shall be to share God's love with the people of the world by providing charity in the form of ministries, financial assistance and gifts of money, food, clothing, etc., and to transact any or all lawful business in the State of Florida.

In carrying out its purposes, the corporation may solicit and receive funds and gifts, or grants of money or property.

No part of the net earning of this corporation shall inure to the benefit or be distributed to any officer or director of this corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes.)

No director or officer of the corporation, or any private individual, shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation.

Notwithstanding any other provisions of these Articles, the corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt under Section 501 (c)(3) of the Internal Revenue Code and its regulations as they now exist or they may hereafter be amended, or by an organization contributions to which are deductible under Section 170 (c)(2) of such Code and regulations as they now exist or as they may hereafter be amended.
