ARTICLES OF INCORPORATION OF THE JOSHUA FRASE FOUNDATION FOR CONGENITAL MYOPATHY RESEARCH, INC.

The undersigned, for the purpose of forming a corporation not for profit under the laws of Fiorida, hereby adopt the following Articles of incorporation:

(A Nonprofit Corporation)

ARTICLE I

NAME

Section 1.1 Name The name of the corporation is The Joshua Fraso Foundation for Congenital Myopathy Research, Inc.

Section 1.2 Address of Principal Office. The address of the principal office of the corporation is c/o Charles C. Lemiey, 200 Laura Street, Jacksonville, Florida 32202.

Section 1.3 Meiling Address. The malling address of the corporation is c/o Charles C. Lemley, 200 Leura Street, Jacksonville, Florida 32202.

ARTICLE II

PURPOSES

Section 2.1 <u>Purposes</u>. The corporation is organized exclusively for charitable, religious educational end scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Specifically, the corporation is organized for the purpose of to fund medical and nutritional research into prevention and cure of congenital myopathies and provide funding for assistance to families of children with congenital myopathies and to undertake such activities as will further the general purposes described herein.

BOARD OF DIRECTORS

Section 3.1 <u>Election</u>. Directors shall be elected in the manner set forth in the Bylaws of the corporation.

Section 3.4 Executive Committee. The Board of Directors may, pursuant to a resolution adopted by a majority of all of the members of the Board, designate two (2) or more of its members to constitute an executive committee, which, to the extent provided in such resolution, may exercise the powers of the Board of Directors.

ARTICLE IV

LIMITATIONS

Section 4.1 <u>Limitations on Actions</u>. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to any member, director, officer or other private person, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to confer benefits on its members in conformicy with the purposes set forth in Section 2.1 of this Article. No substantial part of the activities of the corporation shall be the carrying on of propagands, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States

Internal Rovenue Law) or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue Law).

ARTICLE V

DISSOLUTION

Section 5.1 <u>Dissolution</u>. Upon the dissolution of the corporation, assets shall be distributed to one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government or to a local or state government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
