ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE ONE - NAME

The name of this corporation is Church of Christ, Crestview, Inc.
(hereinafter referred to as the "Corporation").

ARTICLE TWO - DURATION

The duration of the Corporation is perpetual.

ARTICLE THREE - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of the Corporation shall be: 744 S. McDonald St., Crestview, FL 32536.

ARTICLE FOUR - PURPOSE

The specific purpose(s) for which the Corporation is organized is: religious; to teach and preach the gosple of Christ.

ARTICLE FIVE - MANNER OF ELECTION OF DIRECTORS

The manner in which the Directors are elected or appointed shall be stated in the By-Laws. raised or lowered by amendment of the By-Laws but shall in no case be less than three.

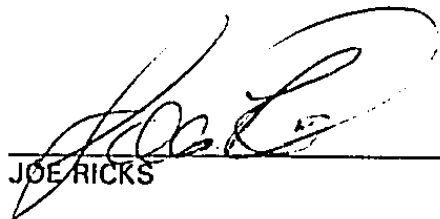
ARTICLE SIX - INITIAL REGISTERED OFFICE AND AGENT
