I, the undersigned subscriber to these Articles of Incorporation, natural person competent to contract, hereby associate for the purpose of constituting a Non-Profit Foundation, to operate in accordance with the laws of God and in a non-profit corporate form pursuant to the applicable provisions of the Statutes of the State of Florida relative to corporations not for profit; and Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law and I hereby covenant and agree as follows:

## ARTICLE I - NAME
