ARTICLE I  
NAME

ARTICLE II  
PURPOSE

The purpose for which the corporation called VICTORY CHURCH THE CHURCH OF GOD IN CHRIST JESUS, INC., is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

ARTICLE X






