PAGE TWO OF ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF LIGHTHOUSE FOR THE LAMB MINISTRIES INC.

FIRST:

Internal Revenue Code, or corresponding section of any futute federal tax code.
