NON-PROFIT

The undersigned, for the purpose of forming a Non-profit Corporation pursuant to Florida law, Section 617 hereby certifies as follows:

ARTICLE I
NAME

The name of this Corporation Not For Profit shall be:

ARTICLE II
PURPOSE



The Directors of this Corporation shall be:

The method of selecting and /or electing Directors will be incorporated in the By-Laws of the Corporation.

ARTICLE VII
QUALIFICATION OF MEMBERS

Members shall be freely admitted to the Corporation, who are willing to promote the purpose of this corporation. The qualification of members shall be set by the by-laws of the corporation. Men, Women, Boys and Girls will be freely accepted to the membership.

ARTICLE VIII

The Minister shall serve as Minister and Executive Director of the said association through the duration of the corporation or he may withdraw in favor of his designee.

ARTICLES IX

The Minister shall serve as Minister and Officer of the said corporation.

ARTICLE X

The Board of Directors shall be composed of not less than (3) members. The Board of Advisors shall be elected by the Board of Directors and members. The Board of Directors and Advisors shall also prepare a set of by-laws for the body of the church organization. The Board of Directors shall be voted upon after each term after the initial appointing of the Directors by the Founder and President.

ARTICLE XI

The County in the State of Florida where the principal office and registered agent for the transaction of the activities of the corporation is located in Dade County.

ARTICLE XII

The property of this corporation is irrevocably dedicated to religious purpose and no part of the net income or assets of this organization shall ever insure to the benefits of any private person. Upon dissolution of the organization assets shall be distributed for one or more exempt purposes within the meaning of section 501 (C) (3) of the Internal Revenue Code or corresponding section of any future federal tax code, or shall be distributed to the Federal, State, or local government for public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes.
