## ARTICLES OF INCORPORATION

SECRETARY OF STATE Non-Profit Organization TALLAHASSIE, FLORIDA

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

#### ARTICLE I Name

The name of the corporation shall be the SEMINOLE COUNTY VOTER'S LEAGUE, INC.

### ARTICLE II Principal place of business and mailing address

The principal place of business of this corporation shall be the geographical area of and within the County of Seminole within the State of Florida. The mailing address of this corporation shall be P. O. BOX 951995, Lake Mary, Florida 32795.

#### ARTICLE III Purpose

The Seminole County Voter's League, Inc. is a non-profit, non-partisan countywide political organization. The specific purposes for which this corporation is organized shall be to promote an informed electorate through voter registration and education, to engage in studies and research voter trends and concerns, economic opportunities and job opportunities, and in other areas that affect the general welfare of the citizens of the County of Seminole, to receive funds from organizations and private sources and to disburse same pursuant to the by-laws, to coordinate activities with similar organizations and individuals with our same purpose and intents in furthering our voting concern for the general welfare of all citizens of Seminole County, to implement programs and projects in keeping with the purposes and intents of this corporation, to interview any potential candidates for public office, conduct political forums, to protect the constitutional and civil rights of individuals, to improve the political, educational, and social and economic status of all people through various types of programs, to lobby against any law(s) which racially discriminates against any minority group citizens, and to take lawful actions to secure its elimination. League may support or oppose any political party, group or candidate.

#### ARTICLE IV Manner of election of directors

The manner in which the directors are elected or appointed shall be
