ARTICLES OF INCORPORATION OF

THE MIAMI KOREAN CHAMBER OF COMMERCE, INC.

(A CORPORATION NOT FOR PROFIT)

We, the undersigned, have associated ourselves as a body corporate with all the rights and privileges granted by the laws of the State of Florida and do hereby adopt Articles of Incorporation as follows:

ARTICLE 1 NAME

The name of the corporation shall be THE MIAMI KOREAN CHAMBER OF COMMERCE, INC.

ARTICLE II PURPOSE

- (A) This Chamber of Commerce (corporation) is organized for the purpose of advancing the commercial, industrial, professional, cultural and civic interests of the Dade, Broward, and Palm Beach County; the promotion of the general welfare, integrity and good faith, just and equitable principles in business; acquisition, preservation, distribution of industrial, commercial, and civic information; participation in representing the city and county in consideration and determination of local, state, national and international issues; promotion of community growth and development.
- (B) The corporation in its activities shall be non-profit, non-partisan, non-sectarian, and shall take no part in or lend its support or endorsement of any candidate for public offices.
- (C) The purpose for which this corporation is formed are purely beneficial, charitable, educational, scientific, and for the express purposes herein set out, and not for financial gain, and no financial gain shall ever accrue to any member of this corporation by reason of his being a member thereof.

ARTICLE III TERM OF EXISTENCE

This corporation shall have perpetual existence unless dissolved according to law.

ARTICLE IV PRINCIPAL OFFICE

The corporation shall have the initial principal office at 20801 Biscayne boulevard, Suite 431, Aventura, Florida 33180.

ARTICLE V MEMBERSHIP

Any person, firm, corporation or association may become a member of the corporation upon payment of the annual dues prescribed by the Bylaws. The Bylaws shall provide the admission process, and may provide for the termination of membership in the corporation for nonpayment of dues.

ARTICLE VI BOARD OF DIRECTORS

The corporation shall have not more than 20 directors and no less than 3, the term of office, election thereof and exact number to be determined by the Bylaws of the corporation. Amendments to these Articles of Incorporation may be proposed and adopted by a majority vote of the board of directors at any annual meeting of the board of directors or at any other meeting of the board of directors provided such notice has been mailed to the directors at least 14 days prior to the time fixed for such meeting, setting forth in substance the proposed

amendments.
