ARTICLES OF INCORPORATION for

GOD'S CALLING ON ASSIGNMENT FOR CHRIST INC.

The undersigned, acting as Incorporator(s) of a corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I - Name

PURPOSE

The purpose of the corporation shall be to cultivate, promote, promulgate and extend the teachings and precepts of the teaching of Jesus Christ. To maintain a Biblical Christian Church, providing a place to worship, to maintain and conduct schools for the religious instruction of the young and further religious missionary, establish educational and charitable works, such as drug rehabilitation counseling and facilities, feeding program for the elderly, and women in distress counseling and aid. This is for all races and public. To teach and help people of all race, creed and color by ways of media.

To make contracts, to receive property by the advice or bequest, subject to the laws regulating the transfer of property, real or personal. To do all acts necessary or expedient for the administration of the affairs and attainment of the purpose of the corporation, including e.g. the establishment of schools, seminars, youth center, etc. oriented to organization principles.

Centers for the aged open to all race, creeds and religious, notwithstanding any of the above mention statements of purposes and powers, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purpose of this corporation.




