### **Articles of Incorporation**

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, hereby adopts the following Articles of Incorporation:

#### **Article I**

The name of this corporation shall be "Burlesque ABE schwa, Inc."

#### **Article II**

The principal place of business and mailing address of this corporation shall be:

#### **Article III**

The specific purposes for which the corporation is organized are:

- i. To promote community awareness, appreciation and support for the arts;
- ii. To provide unique opportunities for artists to collaborate and exhibit original works;
- iii. To foster and support an active local community of artists and lovers of the arts; and
- iv. To develop and encourage an atmosphere conducive to creative artistic endeavor, and a broadly based community commitment to the tolerance, respect, exploration and appreciation of the divergent forms of individual and collective artistic self-expression.

Each Director shall have one vote in all matters regarding the corporation, with the exception that the Founding Director's vote shall control in the event of a tie of all Directors' votes, and that the number and composition of the Board of Directors shall be subject to annual review, re-appointment or replacement by the Founding Director.

## Article V

The corporate powers of this corporation are as provided in § 617.0302, Florida Statutes, except as follows:

Neither the corporation, nor any officer, director, employee or agent thereof, shall be empowered to undertake any action, or to bind the corporation in any manner in violation the requirements for non-profit tax exempt status under the United States Internal Revenue Code.
