OF

A NONPROFIT CORPORATION

Pursuant to Section 617.013, Florida Statutes, these Articles of Incorporation are created by Binder Building Company, Inc., a Florida corporation, as sole incorporator, for the purposes set forth below.

ARTICLE I.

The name of the corporation shall be BOUGAINVILLEA GARDENS CONDOMINIUM ASSOCIATION, INC. The address of the principal office of this corporation shall be 542 11th Avenue South, Naples, Florida 33940, and the mailing address of the corporation shall be the same.

ARTICLE II.
