# ARTICLES OF INCORPORATION

# THE PUTNAM COUNTY FOSTER PARENT'S ASSOCIATION ALLAHASSEE FLORIDA

We the undersigned, with other persons desiring to form a corporation for charitable and philanthropic purposes, under the provisions of Chapter 617 of The Florida Statutes, do agree to the following:

#### ARTICLE I. NAME

The name of this corporation is THE PUTNAM COUNTY FOSTER PARENT'S ASSOCIATION, INC.

## ARTICLE II. ADDRESS

The principal meeting place will be: The HRS Conference Room at Winn Dixie Plaza, Highway 19, Palatka, Florida. The mailing address shall be Post Office Box 2259, Palatka, FL 32178.

#### ARTICLE III. PURPOSE

The general nature of the objects and purposes of this corporation shall be non-partisan, non-sectarian, non-profit organization for the improvement of foster care in the State of Florida by:

- 1. Education
- Communication among foster/adoptive parents as well as between foster parents and the agency (HRS).
- 3. Legislation Children's welfare
- 4. Public Relations Community Awareness
- 5. Miscellaneous as needed

# ARTICLE IV. NOMINATIONS AND ELECTIONS

Section 1. Nominations will be held annually.

Section 2. A nominating committee chosen by the President will make recommendations to the general assembly.

Section 3. Nominations will be permitted from the floor at a regular meeting.

Section 4. To be eligible for office the nominee must be a member of the organization for at least 6 months.

Section 5. Officers should be elected by secret ballot.

Section 6. Vacancies in the office of Vice-President, Secretary and Treasurer shall be filled for the un-expired term by a vote of the general membership at a meeting. In the event the office of the President becomes vacant, the Vice-President shall become President for the remainder of the un-expired term and the Vice-President's office shall be filled for the remainder of the un-expired term by a vote of the general membership.
