ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
RACHEL'S DAYCARE AND PRESCHOOL, INC.

Pursuant to the provisions of Section 617.1006, Florida Statutes (1997), the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: Amendments adopted:

1. ARTICLE I shall be amended in the entirety to read as follows: "The name of the Corporation shall be Hilsdale Christian School, Inc."

2. ARTICLE III shall be amended to include the following additional language: "The Corporation shall admit students of all races, colors, and national and ethnic origins to all the rights, privileges, programs and activities made available to students of the Corporation. The Corporation shall not discriminate on the basis of race, color, or national and ethnic origin in its administration of its educational policies, admissions policies, scholarship and loan programs, or athletic and other school administered programs."
