THE BAY AREA CRUSADER, INC.

The undersigned incorporator, having legal competency to contract, hereby forms a non-profit corporation under the Corporation Not For Profit Act of the State of Florida.

ARTICLE 1 - NAME and ADDRESS

ARTICLE II - DURATION

This corporation shall exist perpetually.

At all times the Corporation shall comply with the provisions of Florida Statutes Section 617.0105, and to the Internal Revenue Code, relating to private foundations.

In order to achieve the corporate purposes, the Corporation's efforts shall be to:

- (a) Publish and generate subscriptions to a periodical newspaper (or other similar format) containing relevant physical and biographical information, photographs and other information concerning crimes and suspected criminals, and how to contact the law enforcement agency requesting such information about those who are "wanted" as suspected criminals;
 - (b) Publish information and photographs respecting missing persons;
 - (c) Publish requests for information concerning unsolved crimes;
- (d) Act as a facilitator and sponsor where appropriate for reward and victim of crimes funds;
- **(e)** Conduct and facilitate the conduct of crime prevention, safety and related seminars:

- (f) Publish news articles, commentary, crime prevention and safety suggestions, and other content designed to educate and inform the public concerning the legal and judicial systems, law enforcement, crimes and criminal activity.


