ARTICLE I - NAME AND ADDRESS

The name of this not-for-profit corporation is FLORIDA YOUTH OPPORTUNITIES FOUNDATION, INC. The mailing address of the corporation is 5018 39th Avenue North, St. Petersburg, Florida 33709.

ARTICLE II - PURPOSE

The purpose of this corporation shall be as follows:
