ARTICLES OF INCORPORATIONS  
OF  
THE LACKAWANNA YOUTH / FAMILY ASSOCIATION, INC.

The undersigned, acting as incorporator of a corporation under the Not-For-Profit Corporation Act, Florida Statutes 617 of the State of Florida, adopt the following articles of incorporation for such corporation:

ARTICLES I

1. The name of this corporation, is The Lackawanna Youth/Family Association, INC.
2. The initial street address in the State of Florida, of the initial principal office of the Lackawanna Youth/Family Association is 441 Day Avenue, Jacksonville, Florida 32254; and the name of the registered agent mailing address is 3215 Hunt street, Jacksonville, Florida, 32254 also the registered agent for Lackawanna Youth/Family Association is Donnell Williams of the mented mailing address.
  - A. I, Donnell Williams by the signing of my name below hereby am familiar with and accept the duties and responsibilities as registered agent for the Lackawanna Youth/Family Association.

ARTICLE II

The period of duration of this The Lackawanna Youth/Family Association Corporation shall be perpetual, commencing from the filing of this instrument with Secretary of the State.

### ARTICLE III

The Lackawanna Youth/Family Association is organized exclusively for charitable, youth athletics, educational, justice, recreational, health and scientific purposes, including for such purposes, the making of distribution to organizations that qualify as exempt organizations under section 501(3) of the Internal Revenue Code, or corresponding section of any Future Funds for scientific, youth athletics, educational justice, recreational, health and charitable purposes within the meaning of the section 501 (3) of the Internal Revenue Code and to that extent, the Lackawanna Youth/Family Association there in, without limitation as to the amount, or value; to dispose of such property and to invest, reinvest, or deal with the principal or the income in such a manner as, in the judgement of the directors, will promote the purposes of the Lackawanna Youth/Family Association within limitation, except such limitations, if any as may be contained in the instrument under which such property is received these Articles of Incorporation, the By-Laws of the Lackawanna Youth/Family Association, or any application laws, to do any other act or thing incidental to or connected with the foregoing purposes or in advancement of, but not for pecuniary profit or financial gain of its directors or officers except permitted under not-for-profit corporation laws.

No part of the earning of the Lackawanna Youth/Family Association shall inure to benefit of any member, director, officer of the Lackawanna Youth/Family Association, or any private individual except that reasonable compensation may be paid for services rendered to or for cooperation affecting one or more of its purposes and no member, director, officer of the Lackawanna Youth/Family Association and private individual shall be entitled to share in the distribution of any of the Lackawanna Youth/Family Association assets on the dissolution of this Lackawanna Youth/Family Association. No substantial part of the Lackawanna Youth/Family Association shall be carry on the propaganda, or other, otherwise attempting to influence legislation and the Lackawanna Youth/Family Association shall not influence, participate, or intervene in, including the publication or statements of any political campaign on behalf of any candidate for public office.

### ARTICLE IV

The Lackawanna Youth/Family Association qualification for members and the manner of their admissions shall be regulated and governed by the By-Laws as ratified with the filing of this instrument.

#### ARTICLE V

1. The Lackawanna Youth/Family Association Board of Directors shall consist of no more than five(5) members, who need not be residents in the Lackawanna community boundaries; but who meet specific qualification set forth by Article IV of this application for incorporation. There can be no less than three directors (3) to serve at any given time. The Directors are elected/appointed according to Article VIII of the Lackawanna Youth/Family Association BY-LAWS.

#### ARTICLE VI

This Corporation, Lackawanna Youth/Family Association is organized under a non-stock basis...

#### ARTICLE VII

Under the dissolution of the Lackawanna Youth/Family Association or the winding up of its affairs, the assets of the Lackawanna Youth/Family Association shall be distributed exclusively to one or more charitable organization which would then qualify under the provisions of, section 501(C)(3) of the Internal Revenue Code and its regulations as they now exist or as they may be hereafter amended, or to the Federal government or to a State or Local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county-in which the principal office of the Lackawanna Youth/Family Association is located, exclusively for such purpose or to such organization or organizations as said shall determine, which are organized and operated exclusively for such purposes.

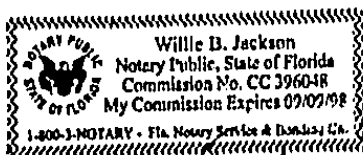
