We, the undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, do hereby adopt the following Articles of Incorporation:

ARTICLE 1

The name of the corporation shall be Shirley Arnold Ministries, Inc.

ARTICLE II

The principal place of business and mailing address of this corporation shall be 741 N Cumbee Rd, Lakeland, Fl 33801-3055.

ARTICLE III

The purposes for which the corporation is organized are:

- (a) The establishment of churches; exclusively;
- The establishment of a Mission or Missions to offer services to the disadvantaged, (b) both in the United States of America and in foreign countries;
- The promotion of evangelism through the establishment of or the use of seminars, (c) concerts, gospel meetings, revivals, conventions, books, tapes, and gospel tracts;
- To have and to exercise all rights and powers that are now, or may be hereafter (d) granted to a corporation by law;
- No part of the net earnings of the corporation shall enure to the benefit of any (e) director individual (except that reasonable compensation may be paid for services rendered to or for the corporation effecting one or more of its purposes), and no director or officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation, no substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervent in (including the publication or distribution of statements) any political campaign on behalf of any candidate for office.
- Notwithstanding any of the above statements of purpose or purposes and powers, this corporation shall not, except in an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purposes of this corporation, and the corporation shall not conduct or carry-on any activities not permitted to be conducted or carried on by an organization exempt from taxation under Section 501(c) (3) of the Internal Revenue Code of 1954 and its regulations as they now exist or as they may hereafter be amended, or by an organization, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1954 and its regulations as they now exist or as they may be hereafter amended.
- Upon dissolution of the corporation or the winding up of the affairs of said corporation, the assets of the corporation shall be distributed exclusively to charitable, religious,

or educational organizations which would then qualify under the provisions of Section 501 (c) (3) of the Internal Revenue Code of 1954 and its regulations as they now exist or may be hereafter amended.

The directors named in these Articles of Incorporation as the first Board of Directors shall hold office until the first annual meeting, at which time an election of directors shall be held. Thereafter, the term of office shall be one year or until the first annual meeting following his/her election and until the qualifications of the successors in office of such director are established.
