Recently, you reported that mail addressed to your foundation at 2471 NW 30 Way, FT Lauderdale FL 33311 had been returned to the sender, in error. You requested that we determine why the errors occurred and provide confirmation that mail delivery for your foundation has been made for several years.

To address your concerns, an investigation was initiated into delivery to your address. Additionally, mailcovers that were previously delivered which you submitted as evidence were examined.

Interviews with delivery personnel assigned to your carrier route and scrutiny of the mailcovers verified that mail addressed to your foundation has been delivered to 2471 NW 30 Way. Delivery personnel also confirmed that delivery has been made for at least three years.

Although we cannot absolutely determine why the errors occurred, it is probable that a delivery employee on another carrier route returned the mail in error.
