ARTICLE ONE
NAME

1.01 The complete legal name of the Corporation is Generations of Miracles Worldwide Ministries, Inc. and the address of the principal office of this Corporation shall be 12605 Ulmerton Road, Largo FL 34644 and the mailing address shall be 12605 Ulmerton Road, Largo FL 34644.

ARTICLE TWO
REGISTERED OFFICE AND AGENT

2.01 The street address of the initial registered office of the Corporation shall be 12605 Ulmerton Road, Largo FL 34644 and the name of the initial registered agent of the Corporation shall be Tony F. HOLTE.

ARTICLE THREE
PURPOSES

3.01 The Corporation is a not for profit corporation. The purposes for which the Corporation is organized are;

(A.) The specific and primary purposes for which the Corporation if formed are to operate for the advancement of religion and for other charitable purposes.

(B.) The general purposes for which the Corporation is formed are to operate exclusively for such religious purposes as will qualify it as an exempt organization under Section 501(C) (3) of the Internal Revenue Code of 1986 or corresponding provisions of any subsequent federal tax laws, including for such purposes, the making of distributions to organizations which qualify as tax-exempt under that code.

(C.) This Corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office.

ARTICLE FOUR DIRECTORS

4.01 There shall be three members of the initial Board of Directors of the Corporation, who will serve until the first election of Directors. The names and addresses of the initial Directors are as follows:
