The undersigned subscriber to these articles, a natural person competent to contract, hereby form a corporation not for profit under the laws of the state of Florida, and under the following articles.

ARTICLE I - NAME

The name of the corporation shall be, Northwest Escambia Little League, Inc.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

ARTICLE III - PURPOSE

The purpose of the corporation shall be to implant firmly in the children of the community the ideals of good sportsmanship, honesty, loyalty, courage and respect for authority. So that they may be well adjusted, stronger and happier children and will grow to be good, decent, healthy, and trustworthy citizens.

ARTICLE IV - ELECTION OF DIRECTORS

An annual meeting of the members of the local league shall be held in September of each year for the purpose of electing board of directors. After board is elected the board shall meet to elect officers.

ARTICLE V - BY-LAWS

ARTICLE VI - AMENDMENT OF ARTICLE OF INCORPORATION

This article may be amended by a majority vote of the Board of Directors of the corporation at any regular or special meeting provided a copy of the proposed alterations, amendments, or recision shall have been furnished to each member of the Board of Directors at least (1) week prior to said meeting.

ARTICLE VII - INITIAL REGISTERED AGENT AND STREET ADDRESS
