ARTICLES OF INCORPORATION
OF
GEORGETOWN BAPTIST CHURCH, INC.

We, the undersigned, with other persons being desirous of forming a corporation for charitable and religious purposes, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following and adopt the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be GEORGETOWN BAPTIST CHURCH, INC., and its principal place of business shall be HC 1, Box 527 (C-309 and Georgetown-Denver Road), Georgetown, FL 32139, with the privilege and right of establishing and maintaining such other place or places of business and offices and agencies elsewhere in the State of Florida, or in any State of the United States, as the corporation may hereafter desire and determine. The name and address of the initial registered agent of this corporation is W. A. JACOBS, SR., physical address is 117 Georgepoint Rd., Georgetown, FL 32139 and mailing address is HC 1, Box 527, Georgetown, FL 32139.

ARTICLE II - PURPOSE

The general purpose of this corporation shall be:

(a) to own, purchase, acquire by gift, rent, lease, sub-lease, devise or otherwise, real and personal property for religious purposes, and to build, erect, construct, provide for, maintain and equip suitable buildings for the benefit, use and occupation of said Georgetown Baptist Church, Inc., its members and congregation.

(b) to establish a Church organization or society to be Baptist in its doctrines; tenets and form of Church government.

(c) to train its members in the teaching of the Bible.

(d) to further, by all proper and legitimate agencies and means the spreading of religious moral and academic instruction as deemed helpful in preparation for a successful Christian life.

ARTICLE III. - MEMBERSHIP

The membership of this corporation shall be the undersigned and all other communicant members now in good and regular standing in the present unincorporated body of professing Christians known as the Georgetown Baptist Church, Inc., and all such other persons as may hereafter from time to time become communicant members of said body, provided, however, whenever, any members of said body shall cease to be a communicant in good and regular standing in said corporation, such person shall cease to be a member of this corporation. The manner, form and requisites of application for admission to membership in said corporation shall be limited to persons approved by membership present at regular services.

ARTICLE IV - TERM OF EXISTENCE

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE VI - MANAGEMENT

The affairs of this corporation shall be managed by a board of three or more trustees, a chairman (the pastor), a vice chairman, a secretary, and a treasurer, and such officers, agents

or employees as may from time to time be elected or appointed. The Board of Trustees immediately upon their election shall be set in office by the Chairman as elected and appointed, vice chairman, a secretary and a treasurer. The manner of election and appointment of other officers and the manner of filling vacancies occurring between the annual meeting of the corporation, by death, resignation or otherwise, shall be prescribed by the by-laws of this corporation. Each member of the Board of Trustees shall be a communicant of said body known as the Georgetown Baptist Church, Inc. (C-309 and Georgetown-Denver Road), P. O. Box 126, Georgetown, County of Putnam, Florida 32139-0126, and in good and regular standing at the time of his or her election. The Trustees shall be elected by the members of this corporation to be held on the first Tuesday in the month of January of each year, beginning in 1997. The office of secretary and treasurer, chairman and treasurer, or vice chairman secretary, may be filled by the same person. The trustees shall have full charge of temporal affairs of the said corporation and the supervision of the properties of the Church. The trustees shall be elected for the term of one year at the annual meeting of this corporation as stated in the By-Laws.

ARTICLE VII - BOARD OF DIRECTORS

and they shall hold office until the first annual meeting of this corporation herein provided for until their successors are elected and qualified.

ARTICLE VIII - OFFICERS

The business of this corporation shall be conducted by the officers of this corporation. The name of the persons who will serve as officers of this corporation are:

ARTICLE IX - BY-LAWS

The By-Laws of this corporation shall be the present By-Laws of said Church and such other By-Laws as may be made and adopted by the members of this corporation which may be amended, altered or rescinded by the corporation in a manner prescribed therein.

ARTICLE X - INDEBTEDNESS & LIABILITY

The highest amount of indebtedness or liability to which the corporation may at any time subject itself shall be determined by the Church membership at said time of proposed indebtedness for the purpose of erecting church buildings or buildings used in connection with the Church or for Church purposes or any of them.

ARTICLE XI - REAL ESTATE

The title to all real estate now owned (if any) by this corporation or that may be here after acquired shall be vested in the Trustees of this corporation and their successors in office. The real estate of said corporation shall not be sold or encumbered except by a vote of majority of members of said corporation present at a meeting called for that purpose.

ARTICLE XII - DISSOLUTION

If for any reason the Georgetown Baptist Church, Inc. should ever be dissolved, all assets and real properties of said corporation shall be used to reimburse investment holders, with the remaining assets to go to Eastland Baptist Church in Orlando, Florida, and said Pastor may act as Independent Trustee or the Baptist Bible Fellowship International of Springfield, Missouri. A vote of the membership of Georgetown Baptist Church, Inc. is required to legalize the process. In the event the above organizations are unable to receive the assets, then an Independent

Baptist Church of like faith and order may receive them having qualified for the exemption under section 501 (c) (3) of the Internal Revenue Code.

ARTICLE XIII - AMENDMENTS

Amendments to this corporation may be made at any meeting called by the Officers, provided notice has been given to the members of this corporation by announcing the same in regular worship services at least two consecutive Sundays prior to the meeting called for that purpose.

ARTICLE XIV - ARTICLES

This corporation reserves the right to amend, alter rescind or repeal any provision contained in these Articles of Incorporation, or any amendment hereto, by a majority vote of those members present at the annual meeting or at any special meeting called for said purpose of altering, amending, rescinding or repealing the said Articles of Incorporation.
