

The Incorporator files these Articles of Incorporation and states:

ARTICLE I  
NAME

The name of this Corporation shall be Concerned Citizens of Dade County, Inc.

ARTICLE II  
PURPOSE

The purposes for which this Corporation is formed are:

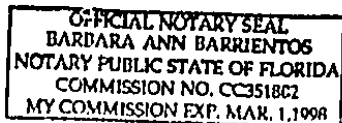
