We, the undersigned, with other persons being desirous of forming a nonprofit corporation, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I.

The name of the corporation shall be:

HIGH SPRINGS GIRLS SOFTBALL, INC.

The address of the principal office of this corporation shall be Southeast U.S. Highway 441, High Springs, Florida 32643 and the mailing address of the corporation shall be Post Office Box 2501, High Springs, Florida 32643-2501.

ARTICLE II.
