

ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

- To accumulate and distribute research materials, for the educational furtherance of the general public, regarding healthcare reform, healthcare practices and changes in healthcare legislation;
- To provide information to healthcare providers and healthcare consumers that is true and accurate and distributed without malice or biased intent.
- To engage in promoting providers proven to uphold quality healthcare and reputable healthcare practices;


