ARTICLES OF INCORPORATION

OF

NFFFA - DOUG MELNE SCHOLARSHIP FUND, INC.

The undersigned, acting as the incorporator of the corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME: The name of the corporation is NFFFA - DOUG MELNE SCHOLARSHIP FUND, INC.

ARTICLE II

REGISTERED OFFICE AND REGISTERED AGENT: The street address and telephone number of the initial registered office is 601 LOMAX, JACKSONVILLE, FLORIDA 32204, (904) 354-1000.

The name of the initial registered agent is BROOKS COLLIER, who is familiar with the accepts of the duties and responsibilities as Registered Agent for said Corporation.

PRINCIPAL OFFICE AND ADDRESS is the same as the REGISTERED OFFICE.

PRINCIPAL OFFICE is the location where service of process can be accepted.

ARTICLE III

PURPOSE: The purpose for which the corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the internal revenue code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE IV

LIMIT OF POWERS: Not withstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue law.

ARTICLE V

ASSET DISTRIBUTION AT DISSOLUTION OF CORPORATION: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state of local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purpose.

ARTICLE VI

DURATION: The corporation shall have a perpetual existence.

ARTICLE VII

BOARD OF DIRECTORS: The election of the board of directors shall be stated in the bylaws of the Corporation. The initial board of directors shall consist of three (3) members. The names and addresses of these persons who are to serve as directors are as follows:
