

SECRETARY OF STATE TALLAHASSEE, FLORIDA

Pursuant to the provisions of Section 617.1006, Florida Statutes, the Florida Network of Children's Advocacy Centers, Inc. a Florida Not For Profit Corporation adopts the following amendments to its Articles of Incorporation:

- 1. ARTICLE IX, OFFICERS, of the Articles of Incorporation be amended as follows:
 - B. The Board shall elect the President and Officers of the Chapter as set forth in the Bylaws. Such officers shall be elected annually by the Board at the annual Board meeting; provided however, that such officers may be removed by the Board and other persons may be elected by the Board as such officers in the manner provided in the By-laws. The President, Vice President, Secretary, Treasurer and a two Directors at Large shall be members of the Board. The same person-may not-hold-more than two offices.
- 2. ARTICLE XI, BOARD OF DIRECTORS, of the Articles of Incorporation be amended as follows:
 - A. The number of members of the Board of the Directors shall be twenty one (21). Thereafter, the number of members of the Board shall be determined by the Board from time to time, but not less than six (6) Directors. The number of members of the Board of Directors shall be the number determined by the Board from time to time, but shall not be less than six (6) Directors.
 - 3. The date of adoption of the amendments was December 2, 2012.
- 4. The amendments were adopted by the members and the number of votes cast for the amendments were sufficient for approval.
