

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby present these Articles for formation of a Corporation not for profit under the Laws of the state of Florida.

ARTICLE I - NAME

The name for the Corporation shall be:

ARTICLE II - PURPOSE OF CORPORATION

The general purpose for which this Corporation is organized is to provide guidance in the discipline of education and all ancillary matters related and engage in any other legitimate activity or business permitted under the laws of the state of Florida and of the United States of America.

ARTICLE III - TERM OF EXISTENCE

This Corporation shall have perpetual existence.

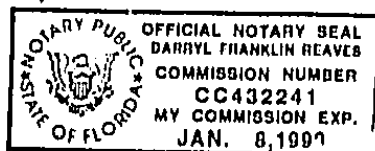
