ARTICLES OF INCORPORATION

ARTICLE 1

The name of the corporation shall be Cathedral of Love Christian Center, Inc. The principle place of business's shall be 12800 N. Il. 6th Avenue Minut Florida 33161.

ARTICLE II

The period of of the duration of this corporation is perpetual unless dissolved according to law. The existence of Cathedral of Lovo Christian Center, Inc. shall commence with the filing of these articles with the Socretary of State.

Article III

The purposes for which the corporation is organized are: To establish and maintain a Inter Denominational Church and to provide a piace of public worship in said County of Dade and the State of Florida; to establish, maintain and conduct schools for the religious instruction of the young, and to further other religious and charitable work, and to that end adopt and establish bylaws, and make all rules and regulations deemed necessary and expedient for the management of it's affairs, in accordance with law and not inconsistant with these articles of incorporation; and to take, manage, hold and dispose of any and all property, real and personal, of said corporation.

Article VII

Any such assets not disposed by circuit or county court in the State of Florida, exclusively for such purpose or to such organization or organizations, as said shall determine, which are organized and operated exclusively for such purpose.
