ARTICLES OF INCORPORATION

ARTICLE I

The name of the corporation shall be Cathedral of Love Christian Center, Inc. The principle place of business shall be 12800 N. W. 6th Avenue Miami Florida 33161.

ARTICLE II

The period of of the duration of this corporation is perpetual unless dissolved according to law. The existence of Cathedral of Love Christian Center, Inc. shall commence with the filing of these articles with the Secretary of State.

Article III

The purposes for which the corporation is organized are: To establish and maintain a Inter Denominational Church and to provide a place of public worship in said County of Dade and the State of Florida; to establish, maintain and conduct schools for the religious instruction of the young, and to further other religious and charitable work, and to that end adopt and establish bylaws, and make all rules and regulations deemed necessary and expedient for the management of it's affairs, in accordance with law and not inconsistent with these articles of incorporation; and to take, manage, hold and dispose of any and all property, real and personal, of said corporation.

Article IV

ELECTIONS FOR DIRECTORS. and the manner of their election shall be provided for in the corporate bylaws.

Article V

The number constituting the initial Board of Trustees of the corporation is four (4), and the names and addresses of the persons who are to serve initially are:

This corporation is organized under a non-stock basis.

Article VII

Upon the dissolution of the corporation, the board of trustees, shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of it's assets exclusively for the purposes of the corporation in such manner, or to such organizations organized and operated exclusively for charitable, religious, and educational purpose as shall at the time qualify as an exempt organization or organizations under section 501(c)(3) of the Internal Revenue Code (or the corresponding provision of any future United States Internal Revenue Laws) as the board of trustees shall determine. Any such assets not disposed by circuit or county court in the State of Florida, exclusively for such purpose or to such organization or organizations, as said shall determine, which are organized and operated exclusively for such purpose.

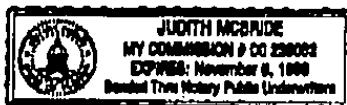
