ARTICLES OF INCORPORATION

OF

HIGH SPRINGS COMMUNITY REVIVAL CENTER, INC.
(a corporation not for profit)

We, the undersigned, with other persons being desirous of forming a corporation for religious, charitable and philanthropic purposes, under the provisions of Chapter 617 of the Florida Statutes, do hereby agree to the following:

ARTICLE I.

The name of the corporation shall be: **HIGH SPRINGS COMMUNITY REVIVAL CENTER, INC.**, and its principal place of business shall be located at Post Office Box 225, High Springs, Florida 32643, or elsewhere in Alachua County as the Board of Directors from time to time by resolution fix.

ARTICLE II.

The general nature and object of the corporation shall be to own, manage, control and deal in real and personal property of every nature and kind for the purpose of conducting Church services of the **HIGH SPRINGS COMMUNITY REVIVAL CENTER, INC.**, and said corporation shall hold all of its property in trust for said purposes and not otherwise and at no time shall any Society, Convention or District or other body or organization have any voice or control in the use or management of the property of the corporation or any part thereof and the Church using said properties shall at all times use the Holy Bible of the Christian faith, King James Version, including both the Old and New Testaments thereof, as its Bible textbook, in Sunday School, regular Church services, Bible School, Prayer Meetings and any other meetings held in said properties.

ARTICLE III.

All present members of the **HIGH SPRINGS COMMUNITY REVIVAL CENTER, INC.**, shall be members of said Corporation, and all members added thereafter in any manner that said Church shall receive members shall also be members of said Corporation; however, no member of this Corporation shall have any vested right or interest whatsoever in the property of this Corporation. The Corporation shall have authority to adopt and amend By-laws providing for the expulsion of members from the Corporation.

ARTICLE IV.

The term for which this Corporation shall exist shall be perpetual.

ARTICLE V.

ARTICLE VI.

The business affairs of this Corporation shall be managed by the President (who shall be the Pastor of the Church), the Vice President (who shall be the Assistant Pastor of the Church), the Secretary, the Treasurer and Board of Directors. The President shall be the Pastor of the Church. The Vice-President shall be the Assistant Pastor of the Church. The office of Secretary, Treasurer and the Board of Directors shall be filled by an election of the members of the **HIGH SPRINGS COMMUNITY REVIVAL CENTER, INC.**, held at the regular annual business meeting of the Corporation which shall be held at the Church on the second Friday in January of each year at 8:00 p.m., or at such other place and time as the Board of Directors may from time to time fix by resolution.

ARTICLE VIII.

This Corporation shall have not less than three (3) directors initially. The number of Directors may be increased or diminished from time to time by the By-laws adopted by the Board of Directors but shall never be less than three (3). The names and addresses of the persons who

may be increased or diminished from time to time by the By-laws adopted by the Board of Directors but shall never be less than three (3). The names and addresses of the persons who are to serve as Directors until the first election are as follows:

The name of "Board of Directors" may be used interchangeably with the name "Board of Deacons".

ARTICLE IX.

The Board of Directors shall adopt the By-laws of the Corporation and may, by a majority vote, amend, alter or resend the By-laws at any duly called meeting.

ARTICLE X.

The Articles of Incorporation may be amended by a majority vote of the membership present at any duly called regular or special meeting of said Corporation upon such notice that said Corporation may by By-laws provide.

ARTICLE XI.

Upon liquidation, dissolution or abandonment of this association, the property, its proceeds and the income therefrom shall not under any circumstances whatsoever inure to the benefit of any private person, but shall be distributed by the last Board of Directors to such charitable corporation as may be selected as having purposes nearest the said purposes of the Corporation. If the last Board of Directors shall not so act, then all of said property shall pass to such Corporation or charitable association as may be selected and ordered by decree of the Circuit Court of Union County, Florida, so that in any event all of said property and the income therefrom shall be irrevocably devoted to charitable purposes.

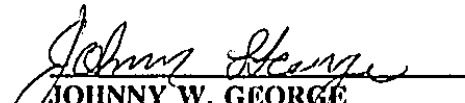
