ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation.

ARTICLE I

Name

The name of the corporation shall be the Tampa Bay Chapter of the United Nations Association of the United States of America, Inc.

ARTICLE II

Principal place of business and mailing address

The principal place of business and mailing address of the corporation shall be:

ARTICLE III

Purpose

The corporation is a local branch of a national group, the United Nations Association of the United States of America, whose purpose as expressed in its national charter is as follows:

"The purpose of the Association is to study and promote the fundamental basis of peace with justice and the machinery necessary for its development. The Association shall carry on educational and informational activities so that the people of the United States of America and their government may participate to the greatest extent practicable in the United Nations and other official international and regional organizations functioning in various fields of international cooperation and international law.

"The Association, in order to implement its overall purpose, conducts programs of research, study, and information to: (a) heighten U.S. public awareness and increase public knowledge of global issues and their relation to the United Nations system; (b) encourage, where appropriate, multi-lateral approaches in dealing with these issues; (c) build public support for constructive U.S. policies on matters of global concern, and (d) enhance the effectiveness of the United Nations and other international institutions."

ARTICLE IV

Manner of election of directors

The directors of the corporation are elected by the membership of the chapter at an annual business meeting, as specified in the by-laws.

ARTICLE V

Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows: no limitation.


