ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION

TEMPLE OF PRAISE CHURCH OF GOD IN CHRIST, INC.

The members and board of directors adopted the following amendment
May 30, 1996.

Adding the following to Article 3:

THE PURPOSES FOR WHICH THE TEMPLE OF PRAISE CHURCH OF GOD IN CHRIST, INC. CORPORATION IS ORGANIZED ARE EXCLUSIVELY FOR RELIGIOUS PURPOSES WITHIN THE MEANING OF SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE OF 1986 OR THE CORRESPONDING PROVISION OF ANY FUTURE UNITED STATES INTERNAL REVENUE LAW.

Adding the following to Article 4:

NOTWITHSTANDING ANY OTHER PROVISION OF THESE ARTICLES, THE TEMPLE OF PRAISE CHURCH OF GOD IN CHRIST, INC. SHALL NOT CARRY ON ANY ACTIVITIES NOT PERMITTED TO BE CARRIED ON BY AN ORGANIZATION EXEMPT FROM FEDERAL INCOME TAX UNDER SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE OF 1986 OR THE CORRESPONDING PROVISION OF ANY FUTURE UNITED STATES INTERNAL REVENUE LAW.

Adding an Article 8 and it shall read as follows:

UPON THE DISSOLUTION OF THE TEMPLE OF PRAISE CHURCH OF GOD IN CHRIST INC., ASSETS SHALL BE DISTRIBUTED FOR ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE, OR SHALL BE DISTRIBUTED TO THE FEDERAL GOVERNMENT, OR TO A STATE OR LOCAL GOVERNMENT, FOR A PUBLIC PURPOSE. ANY SUCH ASSETS NOT SO DISPOSED OF SHALL BE DISPOSED OF BY THE COURT OF COMMON PLEAS OF THE COUNTY IN WHICH THE PRINCIPAL OFFICE OF THE CORPORATION IS THEN LOCATED. EXCLUSIVELY FOR SUCH PURPOSES OR TO SUCH ORGANIZATION OR ORGANIZATIONS, AS SAID COURT SHALL DETERMINE WHICH ARE ORGANIZED AND OPERATED EXCLUSIVELY FOR SUCH PURPOSES.
