**ARTICLES OF INCORPORATION OF**  
**Exceptional Student Education Coalition of**  
**Palm Beach County, Inc.**

**ARTICLE I - NAME**

The name of this corporation shall be Exceptional Student Education Coalition of Palm Beach County, Inc. (the "Corporation").

**ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS**

**ARTICLE III - PURPOSE**

The purpose for which the Corporation is formed, and primary object to be carried on by it is advocacy for education of all children with exceptional needs.

**ARTICLE IV - DURATION**

The Corporation shall have perpetual existence commencing on March 1, 1996.

**ARTICLE V - DIRECTORS**

The Corporation shall have four (4) directors initially. The number of directors may be increased from time to time by the resolution of a majority of the Board of Directors; provided, however, that the Board of Directors consists of not fewer than four (4) directors and no decrease in the number of directors shall have the effect of shortening the terms of an incumbent director. The members of the Board of Directors shall be elected as provided in the Bylaws of the Corporation.

**ARTICLE VI - DISSOLUTION**

Upon the dissolution of the Corporation, all of its assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
