THIS IS TO CERTIFY that I, the undersigned, for the purpose of forming a Corporation Not for Profit under the provisions of Chapter 617. Florida Statutes (1995), do hereby make, subscribe, acknowledge and file these Articles of Incorporation, and I do certify that:

- 1. The name of the corporation is PUNTA CORDA HOUSING AUTHORITY RESIDENT COUNCIL, INC.
- 2. The purpose of this corporation shall be to maintain a viable resident organisation which is representative of the Interests of the public housing residents who reside in the public housing units which are owned and operated by the Punta Gorda Housing Authority; and to improve the lives of said public housing cecidents and promote programs which will provide improved educational, recreational, social service, and economic development opportunities for said the public housing residents; and for the purpose of obtaining official recognition to the fonta borta Housing Authority and from the "botto transite forms and Groan Reverspment as a resident council parameter to HOD regulations; and for the formal to the formal borta formal development for the resident council parameter to HOD regulations; and formal formal and the public housing resident with respect to

maintenance of all housing units and common areas and security and public safety programs.

The purposes for which the PUNTA GORDA HOUSING AUTHORITY RESIDENT COUNCIL, INC. are exclusively religious, charitable, scientific, literary, and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provision of these Articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United State Internal Revenue law.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations, all of which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or inval government for exclusive public purposes

However, the motions of this corporations shall be similed as follows:

a. Any income that may be received by this

corporation shall be distributed in a manner as not to subject this corporation to the fifteen (15%) percent excise tax for undistributed income under Section 4942 of the United States Internal Revenue Code.

- b. Self-dealing, as that term is defined by Section 4941(d) of the United States Internal Revenue Code, shall be prohibited.
- c. This corporation shall be prohibited from retaining excess business holdings, as that term is defined in Section 4943(c) of the United States Internal Revenue Code.
- d. This corporation shall be prohibited from making investments prohibited by Section 4944 of the United States Internal Revenue Code.
- e. This corporation shall be prohibited from making taxable expenditures as that term is defined by Section 4945(d) of the United States Internal Revenue Code.
- 3. The duration of this corporation shall be for perpetual existence.
- 4. The membership of this corporation shall be the subscribers and officers named herein, and all other persons admitted to membership by the Directors: and, qualifications for members and the manner of their admission shall be regulated by the By Laws of this corporation.


