ARTICLES OF INCORPORATION (NON-PROFIT)

- a. The name of this organization is the Tri-State Archers, Inc.
- b. The purpose of the Tri-State Archers, Inc, henceforth referred to as Tri-State, shall be to promote and foster field archery, target archery, bowhunting, and all the other varied activities of archery. The objectives of Tri-State shall be to encourage membership, adopt and enforce rules for the practice of archery, host competitions, and promote publicity about archery.
- c. Active voting membership shall be granted to any individual who has passed his/her eighteenth birthday who has paid Tri-State and National Field Archery Association (NFAA) dues. Membership does require membership in the NFAA. Junior membership shall be granted to any individual who has not reached his/her eighteenth birthday who has paid Tri-State/NFAA dues.
- d. The term for which Tri-State shall exist shall be perpetual.

- f. The affairs of the corporation are to be managed by the Secretary/Treasurer who is appointed by the President. The position of Secretary/Treasurer is a permanent position. All other officers of Tri-State are elected for two year terms of office. The chief officer of the organization is the President. The Board of Directors is made up of the President, Secretary/Treasurer, and a Director. Officers are elected by the members of Tri-State at the last meeting of odd numbered years to take office at the first meeting of even numbered years. The fiscal year of Tri-State shall correspond with the Calendar year. i. The Constitution/By-Laws of the corporation are initially as listed in this document. These shall be maintained current by the Secretary/Treasurer and may be made, altered, and or rescinded by the Board of Directors.

j. Amendments to the articles of incorporation may be proposed and adopted by the Board of Directors of Tri-State Archers Inc. A Simple majority vote of the directors shall be required to affect any change.

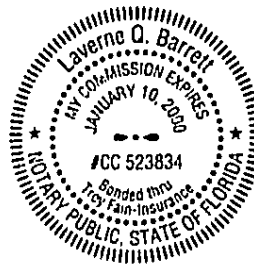
