THE UNDERSIGNED, as President of **BRIDGES OF AMERICA-THE ASHEVILLE BRIDGE, INC.**, a Florida corporation, Florida Document Number N96000001343 (the "Corporation"), pursuant to the provisions of Section 617.1006, Florida Statutes, hereby adopts the following Articles of Amendment to the Articles of Incorporation of the Corporation:


1. Text of Each Amendment. The Corporation's Articles of Incorporation are amended as follows:
 - a. Article I of the Corporation's Articles of Incorporation is hereby deleted in its entirety, and the following is substituted in lieu thereof:

**ARTICLE I
NAME AND ADDRESS**

The name of this Corporation is BRIDGES OF AMERICA - POST TRANSITIONAL HOUSING SERVICES, INC. with its principal office being located at 2011 Mercy Drive, Orlando, Florida 32808-5629 and its mailing address being the same as its office address.
