ARTICLE FIRST: The name of the Corporation is BRIDGES OF AMERICA – THE PINELLAS BRIDGE, INC., and the Corporation's Florida document number is N96000001344.

ARTICLE SECOND: ARTICLE IV - MEMBERSHIP of the current Articles of Incorporation is hereby deleted in its entirety and restated as follows:
