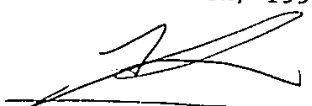
The number of directors may be altered from time to time as set forth in the corporation By-laws. However, the corporation shall have no less than ~~three~~ (3) director at any time.
