# TO THE ARTICLES OF INCORPORATION OF

Pursuant to the provisions of Sections 617.1001 et seq. of the Florida Statutes, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is BUNCHE PARK OPTIMIST OF DADE COUNTY, INC.
- 2. The following amendments to the Articles of Incorporation were adopted by the Board of Directors of the corporation on July 31, 1997 in the manner prescribed by the Florida Not For Profit Corporation Act:

"ARTICLE I: NAME, is hereby amended to read as follows:

The name of the Corporation shall be BUNCHE PARK SPORTS & COMMUNITY CLUB, INC."
