FIRST AMENDMENT OF THE ARTICLES OF INCORPORATION OF LAGUNA PONDS HOMEOWNERS ASSOCIATION, INC. (A Florida Corporation not for Profit)

- 1. The Articles of Laguna Ponda Homeowners Association, Inc., a Florida not-for-profit corporation, were filed in Tallahassee, Florida on March 15, 1996, under Document Number N96000001446.
 - 2. The following Article XI is added to the Articles of Incorporation:

ARTICLE XI EFFECT OF DISSOLUTION ON CORPORATE PROPERTY

In the event of dissolution of the Association (unless same is reinstated), other than incident to a marger or consolidation, all of the assets of the Association shall be conveyed to a similar Homeowners Association or a public agency having a similar purpose.

- 3. There has not yet been a conveyance of any Lake Lots. Therefore, Caribe Century Construction Ltd., the owner and developer of the property, is the corporation's only member. The member has agreed to amend these Articles.
- 4. The members managing general partner, Caribe Group Corp., a Florida corporation by unanimous consent of its Board of Directors, on a meeting held January 13, 1997, has agreed to amend same.
