The undersigned, for the purpose of forming a corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

**ARTICLE I: NAME**

The name of the corporation is ARTS TRIUMPHANT MINISTRIES, INC.

**ARTICLE II: DURATION**

The period of duration of the corporation is perpetual unless dissolved according to law. Corporate existence shall commence upon the filing of these Articles of Incorporation.

**ARTICLE III: PURPOSE**

This corporation is a religious corporation and is not organized for the private gain of any person. A further description of the corporation's purposes is as follows: to provide ministering arts services and performances to the body of Christ and to the needy; to perpetuate and develop the ministering arts; and to reach people with the gospel of Jesus Christ through the ministering arts.

**ARTICLE IV: QUALIFICATION**

The qualifications for members and the manner of their admission are stated in the bylaws of the Corporation.

**ARTICLE V: INITIAL REGISTERED OFFICE AND AGENT  
AND ADDRESS OF PRINCIPAL OFFICE**

The initial registered office and agent of the Corporation will be Colin J. Williams, 9570 Regency Square Boulevard, Jacksonville, Florida 32225. The address of the principal office of this corporation is 9570 Regency Square Blvd., Jacksonville, Florida 32225.

**ARTICLE VI: INITIAL BOARD OF DIRECTORS**

The number of persons constituting the Board of Directors of the corporation shall never be less than three. The number of Directors for this corporation is three
