THE CHALLENGE, INC. OF VOLUSIA/FLAGLER COUNTIES 9: 07 A FLORIDA NONPROFIT CORPORATION

Article 1. Name. The name of the Corporation is: The Challenge, Inc Of Volusia/Flagler Counties.

Article 2. Duration. The duration of the Corporation is perpetual beginning on the 19th day of March in the year 1926.

Article 3. Purposes. The purposes of the Corporation are as follow:

A. This Corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purpose of this Corporation is; To provide comprehensive rehabilitative services focusing on the care of women and their children during and after pregnancy. Through long term residential services, it is our goal to improve the physical health of pregnant/post partum women and their children thereby preserving, enriching, and reunifying families.

B. To exercise all rights and powers conferred by the law of the State of Florida upon non-profit corporations.

C. Provided, however, that the Corporation shall not engage in any action which is not permitted to be carried on by non-profit corporation under the Internal Revenue Code, 501 and no part of the net earning of the Corporation shall inure to the benefit of or be distributable to its members, directors, or officers; but the Corporation shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and to make payments and distributions in furtherance of its stated purposes.

Article 4. Members. This Corporation shall have no members as stated under 617.0601(1)(a) Florida Statute.

Article 5. Initial Registered Agent and Office. The initial registered agent is Martha Arcaya and the initial registered office is 851 Orange Avenue, Daytona Beach, Florida 32114, the principal office and the registered office are the same.

Article 6. Initial Board of Directors. The initial Board of Directors shall be 5 members whose names and addresses are:
