

The undersigned, acting as incorporator of a corporation under the Florida Not-For-Profit Corporation Act, Chapter 617, Florida Statutes, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is Seacoast Songwriters Series, Inc.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose is to enhance the existing music arts programs in the area and expand the opportunity to promote cultural growth in our community.

ARTICLE IV

The corporation will be a non-stock not-for-profit corporation.

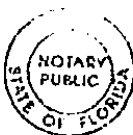
